

In 2001 I became legally blind, due to macular degeneration. At that time I was aware of an organization called SAIL. My understanding was that the organization was there to assist seniors and people with disabilities. At that time, I was losing my ability to use the computer. I sought help from my local SAIL office in Sitka. I was provided with training in software that made the computer accessible. With the help from Jerry Kainulainen and the SAIL organization; I was able to access and fully utilize my computer.

Several years later I joined the Board of Directors because I wanted to help others the way SAIL helped me. From my position now, I am able to see the overall impact that SAIL has on so many people in Southeast Alaska. Needless to say, I am proud to be a member of SAIL. I only wish I could personally thank each of the businesses, organizations and individuals who support SAIL through your financial contribution and volunteer efforts. We could not have the life changing impact on so many without you.

We are excited to share our Fiscal Year 2014 Annual Report with you. Most Likely you are receiving this because you have been a part of making our efforts successful. Because of you, and other philanthropic minded people like you, SAIL will continue *inspiring personal independence* for seniors and people with disabilities.

A few 2014 Highlights include:

Our HomeMAP Program (a program which ultimately helps seniors and people with disabilities live at home longer, safer and more independently) gained state-wide recognition. SAIL staff traveled to other Centers for Independent Living in the state to train them in order to replicate the program across the state. The HomeMAP product was officially trademarked!

Joan O'Keefe, SAIL's Executive Director was nominated and awarded a Rasmuson Foundation Sabbatical. We are looking forward to her return in January of 2015.

SAIL was chosen as the Alaskan Brewing Company's charity of the year and received over \$20,000 from their "tip jar" and other special events. We are so grateful.

Seimeen Bone of Sitka organized another successful fundraiser for SAIL- The 6th Annual Red Dirt BBQ Country Music Concert. Ms. Bone has raised over \$14,000 for SAIL since the events inception six years ago. Amazing!

Don Brandon

November 25, 1953 - May 1st, 2014



SAIL and the entire disability-rights community lost a good friend this year. Don Brandon was a terrific self-advocate and advocate for others. He was an encyclopedia on the Americans with Disabilities Act (and the Amendment Act of 2010). He helped start the Midnight Sun Wheelchair Race and was the first winner of the race – at the time it was 368 miles long from Fairbanks to Anchorage. He spent his entire career dedicated to improving the lives of people with disabilities in a variety of jobs, most recently as the Accessibility Coordinator at SAIL. He was also a past member of SAIL’s Board of Directors. He started his career as the director of the Easter Seals in Fairbanks; he spent many years as the State of Alaska’s ADA Coordinator before moving to Washington to run the Northwest ADA Center. It was always a pleasure to work with Don, he was easy to work with, so smart, and so much fun to be around. Don made a huge impact on all of us at SAIL and we miss him very much.

and **166** individuals with **VOCATIONAL SERVICES**.

641 individuals received **SKILLS TRAINING**.

273 RECREATION opportunities were offered

and **SIGN LANGUAGE INTERPRETERS** were provided

on **132** different occasions!


Rhonnie

Initially, Rhonnie was shy, nervous, hesitant and over-stimulated by the wild energy of ORCA's elementary youth. Fast forward a year and a half and we find an empowered young woman willing to take a leadership role in working with young children. Rhonnie completed her first work experience with Eaglecrest Snowsports School "Wee Ski" program last season and is hoping to be hired to work at Eaglecrest this coming season!

TIM

Tim Huber was a successful and busy AP journalist covering the West Virginia mining industry when he had a major stroke that severely impacted his mobility and communication. When he and his family moved to Haines last year, Tim brought an exuberant and resilient spirit and immediately set out to make himself an active member of the community. Of first order, he and his wife Helen sought SAIL's assistance in connecting Tim to volunteer opportunities. Soon Tim was volunteering weekly at the library as well as special events such as the Southeast Alaska State Fair. Through a donation to SAIL, Tim was able to receive a small electric cart and began driving himself around town. He was itching to work so SAIL connected him to the Department of Vocational Rehabilitation (DVR) and assisted him with employment development and on-going supports. Tim is working as a farmhand with an amazing employer (18 Meadows Farm near Haines) who accommodates his needs for adaptive equipment and extra time to complete tasks. Tim drives the tractor, processes and sorts crops, and sells the harvest at the local farmer's market. SAIL also applied for and was awarded a grant from the Alaska Brain Injury Network which is paying for training in activities of daily living such as cooking and laundry. SAIL is currently collaborating with DVR on funding for driving instruction and an adaptive accelerator pedal for a standard car so that Tim can take his driving test, receive an Alaska license, and begin driving himself to work. Tim is an asset to his community and a role model to anyone who strives to be a productive and active lifetime learner despite obstacles. SAIL is proud to be a part of Tim's story and inspired personal independence!






