Our primary focus is to create and grow endowments which are permanent pools of assets that generate income to support the causes our communities care about.



### HOW DOES AN ENDOWMENT WORK?

An endowment is a “savings account” that grows through financial contributions from donors and strategic investing. The Alaska Community Foundation offers a well-balanced, diversified portfolio that focuses on long-term growth. The proceeds earned are used to support nonprofits or projects in the endowment’s area community needs and make effective grant recommendations.

Donors to endowments want to ensure the future prosperity of their community. Gifts to endowments don’t have to be large to make a significant impact.
