Employment Update

- ❖ Sierra and Megan are continuing to move forward with our Pre-Employment Transition Services (PETS) projects in Haines and Juneau
- ❖ Sierra met with Sarah Watkins, Division of Vocational Rehabilitation (DVR) over several days in Haines to collaborate on folks involved in PETS as well as other employment related fees for service
- ❖ Keith Smith met with Jim Swanson, Regional Director for DVR, to discuss vendor services out of the Ketchikan office
- ❖ Sierra will be conducting a training for SAIL staff on September 21st on the topic of increasing employment referrals from DVR.

Secure Office Space that is inviting, accessible to those served ad affordable for the organization

- Secured \$75K from the Trust for accessible office space in Haines (special shout-out to Sierra for a job well done!) SAIL will be located on the first floor with other service providers. Veterans Housing on the second floor.
- Signed a new lease in Ketchikan, effective October 15th. Relative to our current location, this new office will have improved parking, accessibility, and community visibility. Special kudos to Keith, our Ketchikan Program Director, for giving up a window to the outside world in favor of a better location for consumers and the public.
- In Juneau, we are continuing to work with the United Human Services (UHS) on potential options to relocate with other social service non-profits. A non-profit center is currently included in plans for Phase 2 of the Housing First project as well as in a proposed Assisted Living Center. Meanwhile, SAIL Juneau is co-located with five non-profits, sharing a board room and janitorial services. The building location is accessible by bus however the building itself has many accessibility short-comings and is not designed to fully realize the potential benefits of co-location with other social service non-profits.
